




How to Access Scheduled Hearing Information

Access your scheduled hearing information by **downloading** the **Notice of Hearing**.

1. Click on the  **Dashboard** icon, to get to the **My Cases** screen.
2. The **My Cases** screen will display a list of all current cases.
3. Once a hearing is scheduled, a date and time to appear for hearing will show under **Hearing Date & Time** (see example labeled **3**).

If a hearing is **not** scheduled, the hearing date and time will be **blank**. Check back for updates.

4. When the **Hearing Date & Time** are available, click on the **linked** case number and go directly to the **Case Number** screen.

Case Number Screen: Download the Notice of Hearing

To download the **Notice of Hearing**:

1. Find the **CASE DOCUMENTS** section. Listed below it, are case related documents.
2. Find a document with a title that starts with, *“Hearing Notice”*.
3. Located to the right of the *“Hearing Notice”* document, you will find a **Download** icon. **Click** on the icon to download your **Notice of Hearing**.

****To view the downloaded document, you may have to disable the pop-up blocker in the browser setting before downloading.**
